## **Terms and Conditions**

Please read these terms and conditions carefully. By accessing the Behavioural Finance Australia ("BFA") web site or any of the services provided by BFA, you are indicating that you have read, acknowledge and agree to be bound by these Terms and Conditions. Simon Christopher Russell has entered into this agreement with you as trustee for the BCF Consulting Services Trust (trading as Behavioural Finance Australia) and on as agent and trustee for its Related Entities and Representatives, and may enforce the performance of this agreement on behalf of its Related Entities and Representatives in its name or in any of their names.

#### A. BFA SERVICES

#### a. What are BFA Services?

BFA Services include information and analyses contained on BFA's web site, in emails, reports, presentations or as part of any other service provided by BFA (collectively referred to in these Terms and Conditions as "BFA Materials").

The types of BFA Services available to BFA clients can be found on our web site, and described in BFA's various brochures, flyers, emails and other marketing materials from time to time.

Each BFA Service may be subject to Terms of Use specific to that service. Where a Terms of Use conflicts with these Terms and Conditions, the Terms of Use relating to the specific BFA Service will apply.

#### b. Registering for a BFA Service

When providing information when registering to obtain BFA Services, you agree to provide BFA with accurate and complete information. It is your responsibility to inform BFA of any changes to that information.

#### c. How much do BFA Services cost?

Some BFA Services are provided for free and others require payment of a specific fee. Details of the fees associated with any BFA Services, how to pay and when to pay those fees can be found on our web site or as described in BFA's various brochures, flyers, emails and other marketing materials from time to time.

BFA is not obliged to provide any BFA Service until such time as fees associated with that particular BFA Service have been paid.

Where BFA supplies BFA Services on credit, it can at any time cease with immediate effect supplying those BFA Services where you fail to pay the fees associated with those services in accordance with the payment terms.

### d. Rights of BFA customers

You are entitled to post on BFA's online forums or blogs where access is provided to do so. When posting on the BFA website you agree that you shall not post, publish, upload or distribute any messages, data, information, text, graphics, links or other material (collectively 'Postings') which are unlawful or abusive in any way including but not limited to any Postings that are defamatory, libelous, pornographic, obscene, threatening, invasive of privacy or publicity rights, inclusive of hate speech, or would constitute a criminal offence, violate the rights of any party, or give rise to liability or violate any local, state, federal or international law.

#### f. When we offer a Satisfaction Guarantee it only covers what is specified

In limited cases BFA may provide a satisfaction guarantee component to a specific BFA Service. Where this occurs the details of the satisfaction guarantee will be contained in the information describing the relevant BFA Service.

#### B. USE OF BFA SERVICES

#### a. How do I use BFA Services, including BFA Materials?
